Los Angeles Superior Court Grants Emergency Application to Allow the State Bar of California to Assume Jurisdiction of the Law Practice of Mitchell Roth

Los Angeles, CA, February, XX, 2009 – United First, Inc. today announced that on Wednesday February 11, 2009, the

Los Angeles Superior Court granted an emergency application filed by the State Bar of California (Trial Counsel Office) to assume jurisdiction over the law practice of Mitchell Roth and the Mitchell Roth Law Offices.

Under the terms of the order, all calls to the Roth office will be referred "to a specific telephone line at the State Bar, which shall be established to receive the calls." Any interested party who wants to call the State Bar directly can call (213) 765-1649.

The court also ordered that the State Bar be appointed to do the following, among other things:

- Notify persons and entities who appear to be clients, advise them of Mr. Roth's incapacity, of the pendency of this proceeding and reasons for the proceeding, and inform them that it may be in their best interest to obtain other legal counsel.
- Apply for extensions of time as necessary, pending employment of such other counsel by the client.
- With the consent of the client, file notices, motions and other pleadings on behalf of the clients where jurisdictional time limits are involved and other legal counsel has not yet been obtained.

United First Inc. will continue its cooperation with the State Bar proceedings.
